 - a. Summary under construction.
- 13. UF postdoc salary Dr. Peggy Wallace
 - a. UF postdoctoral associate salary minimum will be brought up to \$47,476 in line with the new labor law: http://hr.ufl.edu/manager-resources/classification-compensation/flsa/.

<u>Postdoctoral associates</u> are OPS faculty, not fellows, so they will be raised to a minimum of \$47,476. Although they are UF employees, they are not eligible for state healthcare benefits because they are appointed OPS. For these postdocs, their PIs will be required to come up with additional funds to bring salaries up to the minimum, however there is some financial assistance available from UF for increases over \$4000 (http://hr.ufl.edu/manager-resources/classification-compensation/flsa/postdoc/).

[Note: Postdoctoral fellows are paid on NIH training grants/fellowships, so are not considered UF employees. Thus, the FLSA rule normally wouldn't apply here. However, NIH is bringing fellowship and training grant minimums up to \$47,476 and will be raised by NIH increases to those grants.]

- 14. Student professionalism Dr. Peggy Wallace
 - a. Dr. Wallace queried the faculty council representatives regarding issues with assessing student professionalism and accountability for professionalism. No strong desire to discuss further for now.
- 15. ELAM presentation on Women in Medicine Dr. Sonal Tuli
 - a. This work was from Dr. Tuli's participation in the Executive Leadership program of AAMC. From 2013-14 data, while 46-47% of medical students and residents were women, they constituted only 21% of professors and 16% of Deans at academic medical centers. UF 2015: About 41% of Assistant Professors were women (compared to 44% nationally); about 26% in Associate professors (compared to 33% nationally), and UF had about 16% Professors (22% nationally). In recent years, the trend in the difference between national and UF levels has widened at the Associate and Professor level, due to the percentage of women faculty remaining fairly static here while it has been increasing nationally. UF COM has fewer female Chairs than the national average as well. Dr. Tuli indicated that some specific relevant analyses of Faculty Forward data would be forthcoming, and she provided suggestions for improving the numbers of women at different academic ranks, such as clarifying expectations about role and progression to promotion, more opportunities, and improving workplace culture. Barriers to this include implicit gender bias and imposter syndrome, the latter of which is a bigger problem among women.
