#### Minutes:

- 1. President Peggy Wallace called the meeting to order at 5:02PM.
- 2. Introduction of new department representatives Peggy Wallace, Ph.D. Dr. Natalie Silver – Otolaryngology.
- 3. The April 2017 Faculty Council meeting minutes were approved.
- 4 Executive Committee report Peggy Wallace, Ph.D.
  - a. Dr. Patrick Duff and Dr. Lisa Dixon discussed Residency Match results for current UF medical students and incoming residents from other programs. 65% of UFCOM graduating medical students matched with their first choice of schools. It appears that scores on the Step 1 and Step 2 exams are taking increasing importance in this procedure nationwide. Among incoming residents, there are fewer this year from UF and Florida in general compared to last year.

- b. Dr. Glenn Morris gave an update about the Emerging Pathogens Institute, which received one of only four Vector-borne Disease Regional Centers of Excellence Grants from the CDC for \$10 million last year. (Three other institutions collaborate on this grant, University of Miami, Florida International University and University of South Florida) <a href="https://news.ufl.edu/articles/2016/12/four-state-universities-collaborate-on-10-million-center-to-address-zika-and-other-diseases.php">http://news.ufl.edu/articles/2016/12/four-state-universities-collaborate-on-10-million-center-to-address-zika-and-other-diseases.php</a>) Dr. Morris' EPI presentation is posted on the Faculty Council website under the Minutes and Attachments section.
- c. Four finalists for the Surgery Chair position are returning to UF for comprehensive three-day visits. Six Dermatology Chair candidates are coming to UF for their first visit. One PA Director candidate has been interviewed so far.
- d. The Salary Equity Study is complete and corrections are being implemented. Currently, Department Chairs are allowed to request salary adjustments one time per year, but that may be changed to once per month if the requests are based solely on equity. As a reminder, all salary increases must be approved by the Vice President's office.
- e. Dr. Limacher gave an update about the Distinguished Professor Awards. This prestigious award recognizes faculty members who have an exceptional record of achievement in at least one mission while being strong in at least one other mission. There are currently only 3 or 4 faculty members in the COM with this title. These awards were previously selected through the Promotion & Tenure committees, which has caused confusion because it is not a promotion. Therefore, a new committee will be formed to go through nominations and select awardees, likely once a year.
- f. Dr. Limacher updated the Faculty Onboarding document for new faculty, which can be found on the Faculty Affairs webpage at: <a href="http://facultyaffairs.med.ufl.edu/new-faculty/new-to-uf/faculty-onboarding/">http://facultyaffairs.med.ufl.edu/new-faculty/new-to-uf/faculty-onboarding/</a>. It includes the HSC walking tour that was suggested by Faculty Council, and provided by council members.
- g. The Dean stated that the COM budget is right on track with the projected numbers for this year.
- 5. Curriculum Committee no updates.
- 6. COM Promotion & Tenure Oversight Committee Laurence Solberg, M.D.
  - a. This committee is in the process of scheduling a meeting. The multi-mission educational track is currently being reviewed.
- 7. COM Compensation Committee no updates.
- 8. EFAC no updates.
- 9. Faculty Senate Lauren Solberg, J.D.
  - a. Dr. David Quillen, an Associate Professor in the College of Medicine Department of Community Health and Family Medicine, will begin his term as UF Faculty Senate Chair in July of 2017.
  - b. Dr. Katie Vogel Anderson, a Clinical Assistant Professor in the College of Pharmacy, was elected as the UF Faculty Senate Chair-Elect.
- 10. Update on the COM Ombuds Program Dr. Keith Stone
  - a. Dr. Stone reported that he has met with three departments so far to discuss the COM Ombuds Program (Neurology, Orthopaedics, and Radiation Oncology). He is

scheduled to meet with five more departments in the near future (Anesthesiology, Biochemistry, Otolaryngology, Surgery, and Obstetrics & Gynecology). His goal is to meet with at least half of the departments by the end of June. He plans to attend a campus-wide Ombuds meeting next week and a statewide meeting in Tallahassee on July 28, 2017.

# 11. Old business – Peggy Wallace, Ph.D.

- a. A call for nominations will soon begin for the positions of Vice President and President-Elect for COM Faculty Council. Nominee names with a brief bio (1 paragraph) can be submitted to Melissa Liverman (<u>liverman@ufl.edu</u>). Deadline for nominations is May 3, 2017. The election will be held electronically from May 6 – May 24.
- b. Congratulations to the recently elected COM Faculty Senate representatives: Vincent Bird, M.D., Jason Byrd, Ph.D., Margaret Lo, M.D., Scott Myers, M.D., and Lauren Solberg, J.D.
- c. Departments now have the opportunity to purchase parking vouchers to provide (at their discretion) to their offsite clinical faculty who need short-term parking when on campus for meetings, etc. Departments are not required to purchase the vouchers. Contact Dr. Peggy Wallace or Dr. Marian Limacher with questions or concerns.
- d. The proposed 401(a) Supplemental Retirement Program mechanism will be implemented soon.
- e. Annual Chair Evaluations will be initiated in the very near future. Look for the email announcement and remind your faculty. The evaluation must be completed in one sitting, but it is shorter than last year and offers the opportunity to give comments for specific items.

### 12. New business – Peggy Wallace, Ph.D.

- a. Planning for next year: ask your department faculty for ideas for future projects and speakers and provide that information to Dr. Wallace.
- b. The fringe benefit rate is being raised to 18.3% for clinical faculty (up 2%), to match expenditures.
- c. Attendance was slightly down at the Spring COM Faculty Reception this year. The faculty representatives that were unable to attend were polled to see if there were specific reasons why they didn't attend this year. Most attributed it to scheduling conflicts.
- d. If your term on the Faculty Council is expiring this summer, please remind your Chair to have an election for a representative during the next month. There are no term limits.
- e. Dr. Limacher's office is revising the faculty mentoring policy and would like faculty input. An email has been sent out. - 14. <u>3D Printing and UF's Institutional Repository at the HSC Library</u> Hannah Norton, Interim Director; Reference & Liaison Librarian, Health Science Center Libraries
  - a. 3D printing is available at the HSC Library, Marston Science Library, and the Education Library. To request 3D printing, submit your model as an STL or OBJ file electronically to: <a href="http://3dprint.uflib.ufl.edu/">http://3dprint.uflib.ufl.edu/</a> or bring your file to the library on a flash drive. The fee for this service is \$0.15 per gram of material used (miniumum of \$3). For more information, visit: <a href="http://guides.uflib.ufl.edu/3dprinter">http://guides.uflib.ufl.edu/3dprinter</a>.
  - b. Available 3D printing equipment includes: the MakerBot Replicator 2 model, the Fusion F306 model, and the NextEngine 3D Scanner model (steep learning curve on this model).
  - c. Users will need to choose the resolution level (0.1 mm 0.3 mm), infill (honeycombinfill [by default] or solid), and whether or not to use rafts/supports on the models.
  - d. Programs that can be used to download a model include: Thingiverse; Trimble 3D; Smithsonian; YouMagine; GrabCAD; and yeggi.
  - e. The NIH 3D Print Exchange can be accessed at: <a href="http://3dprint.nih.gov/">http://3dprint.nih.gov/</a>. A free log-in is available if needed. Users can find models uploaded by other users, create

- printable models from other image types, and share their own models.
- f. Programs that can be used to create your own models include: Tinkercad, 123D Catch/Make (for simple models); Skechup (for medium models); and Solidworks, Inventor, AutoCAD, Blender and Maya (for complex models). Note that not all 3D modeling software is designed for 3D printing. UF Apps offers many of these programs for students and faculty at: <a href="http://info.apps.ufl.edu/">http://info.apps.ufl.edu/</a>.
- g. The <u>Institutional Repository</u> at the University of Florida (IR@UF) is the digital archive for the intellectual output of the UF community, and includes research, news, outreach, and educational materials. Additional information can be found at: <a href="http://ufdc.ufl.edu/ir">http://ufdc.ufl.edu/ir</a>.
- h. The following materials can be uploaded into the IR@UF: journal articles; conference papers and proceedings; monographs and monograph series; technical reports; theses and dissertations; white papers; data and data sets (stand-along or with publications); journals and other publications of UF colleges; and grant proposals.
- i. Materials that are uploaded into the IR@UF must be complete, must be scholarly content created by members of the UF community, and the person posting the materials must retain the rights to do so. From the IR@UF main page (<a href="http://ufdc.ufl.edu/ir">http://ufdc.ufl.edu/ir</a>) click the "Publish" button, then click the "Submit your research" link.
- k. To make changes to uploaded materials, log-in to myUFC, open the item, and click "View all my submitted items". Each item is labeled with a unique identifier after the base: <a href="http://ufdc.ufl.edu/">http://ufdc.ufl.edu/</a>. Then choose "Edit Metadata", "Edit Behaviors" and/or "Manage Files". These selections can be navigated by using the gray bar at the top of the page or by using the drop down from the "Manage" tab.
