4. Committee Reports:

- President's Report Albert Robinson, III, M.D.
 - The Faculty Council serves as a forum for shared governance and mutual exchange of ideas between senior officers of the College of Medicine and faculty to advance the mission of our great institution.
 - Plans for the Faculty Council CARES initiative were introduced that include moving forward with advocacy for diversity and inclusion, wellness, as well as advocating for community engagement for health equity and access.
- Executive Committee report Albert Robinson, III, M.D.
 - Dean Tyndall focused on the Climate of Diversity, Inclusion, Equity and Community Engagement.
 - Dr. Joseph Fantone and Dr. Julia Close discussed policies and guidance for COVIDrelated impacts for our medical students, residents and fellows.
 - Dr. Stephen Sugrue provided COM research updates.
 - Jeremy Sibiski provided the COM Finance & Administration report, FY21 budget status, and 2020 projections.
- Update on Chair Searches Albert Robinson, III, M.D.
 - Dr. Jennifer Hunt has been selected as the new Chair of the Department of Pathology,
 Immunology & Laboratory Medicine, effective August 1, 2020.
 - The chair search for the Department of Epidemiology is almost complete. The new chair should be announced soon.
 - The COM Dean's Search is ongoing. The search committee completed their initial interviews with several applicants and submitted their recommendations to Dr. David Nelson. Dr. Nelson will now work with a search firm to coordinate virtual interviews with the applicants and COM leadership in place of the campus visits.
- Faculty Lounge art Emily Weber LeBrun, M.D.
 - Dr. Weber has received 122 submissions of faculty artwork to be displayed in the Faculty Lounge. The committee discussed purchasing a few electronic digital frames for the lounge to showcase all of the art.

 - There is a shortfall of collections for the month of May. However, the total number of visits per week (including telemedicine visits) equaled the number of visits for that time frame in 2019, which is encouraging news.
 - The Faculty Compensation Plan was discussed and will be deliberated upon further once the Compensation Committee, chaired by Dr. Mark Scarborough, reconvenes in August 2020. The Faculty Council will have representation on this committee.
- Research Task Force Jean Cibula, M.D. for Kimberly Sibille, PhD
 - New members have been added to the Research Task Force. The next meeting will be held on July 16, 2020.
 - A number of resource documents are being developed and will be posted on the Faculty Council website by August 2020.

 - The Faculty Council officers are meeting with Linkage representatives on July 10 to discuss distribution of the survey results.

We are pleased to announce that GatorCare has contracted with PreventionGenetics to perform medically necessary genetic testing for our members effective July 1, 2020. Testing through PreventionGenetics will be

covered at the Tier 1 level of benefits – this means that the Tier 1 CY Deductible is waived and the member is responsible for 10% of the contracted rate (except for the Healthy Rewards HRA and HSA compatible plans, where the CY Deductible applies).

PreventionGenetics Labs has an exceptional reputation and a large testing library. The lab's website, www.PreventionGenetics.com, contains the test descriptions by gene and by disease, as well as the specimen requirements and shipping instructions.

Cytogenetic testing such as chromosomes, microarray studies and cancer cytogenetics should still be sent to **UF Pathology**: www.pathlabs.ufl.edu/client-services/requisitions.

GatorCare has contracted with Heather Stalker, MSc, CGC, a board- certified genetic counselor to assist with:

- Selection of appropriate test products, when requested
- Determination of medical necessity
- Assistance in reviewing/interpreting significance of results of testing, when requested
