Minutes:

- 1. The meeting was called to order at 5:00pm.
- 2. The minutes from the July 11th, 2023 meeting were approved.
- 3. Updates from UF Research David P. Norton, Ph.D., Vice President for UF Research
 - Dr. Norton referred to the recent legislative session and stated that not only did many positive things come out of it, but many positive things are also happening here at UF.
 - The research expenditure numbers have not yet been announced, but they are going to be a positive story and he looks forward to releasing that information.
 - UF remains very highly ranked as an institution.
 - The State Legislature allocated an incredible amount of new recurring dollars to the University of Florida, much of which has been distributed to the units based on a formula that the President put forward.
 - Dr. Norton referred to challenges presented through the recent legislative session and discussed the following Senate Bills as they relate to research.
 - SB 846, Agreements of Educational Entities with Foreign Entities; Prohibiting state universities and state colleges from accepting grants from or participating in partnerships or agreements with a college or university based in a foreign country of concern or with a foreign principal unless specified conditions are met;

providing an exception; authorizing state universities to enter into partnerships or agreements with a college or university based in a foreign country of concern or with a foreign principal if such partnerships or agreements are approved by the Board of Governors and specified requirements are met; authorizing the board to sanction and withhold performance funding from a state university for entering into an unauthorized partnership or agreement; requiring each state university and state college to annually submit specified information to the Board of Governors and the Department of Education, respectively, by a specified date, etc. (effective July 1, 2023)

- <u>SB 266, Higher Education</u>; Revising the duties of the Board of Governors relating to the mission of each state university; requiring the Board of Governors Accountability Plan to annually report certain research expenditures of a specified amount; prohibiting specified educational institutions from expending funds for certain purposes; revising how general education core courses are established; specifying a one-time limit on requirement to change accrediting agencies, etc. (effective July 1, 2023)
- Dr. Norton stated that the Office of Research is working with UF General Counsel's office to determine what adjustments may need to be made to comply with these statutes. Challenges to work through with SB 846 include adjusting agreements with specific collaborators, as well as clarifying questions about honorariums and travel expenses for faculty who go to the foreign countries of concern to present lectures. A key challenge to work through with SB 266 is how to adhere to the provisions in the statutes while continuing to meet expectations from federal funding agencies such as the National Institutes of Health (NIH) and the National Science Foundation (NSF).
- Dr. Norton has had this discussion with university leadership, college deans, general counsel, and contacts within the Board of Governors staff. The intent is to navigate through this so that our researchers can keep doing great work and meet the expectations from the agencies to move forward.

4. New Business:

- Announcing the annual State of the College Address in the Fall Erica Dale, Ph.D.
 - Dr. Dale announced the upcoming <u>2023 State of the College Address</u> to be held on Friday, September 29, 2023 from 7:00am – 8:00am in the Harrell Medical Education Building, Learning Studio 125.

5. Old Business:

- Update on plans for President-Elect and Vice President elections for Faculty Council
 - A call for nominations was sent out for the Faculty Council President-Elect and Vice President. A college-wide election will be held this month and the newly elected officers should be in place by the September 2023 meeting.
