- 2. The minutes from the January 9th, 2024 meeting were approved.
- 3. Priorities and Goals for GatorCare in 2024 Billy J. McCarty, M.D., M.B.A., President & Medical Director, GatorCare
 - Dr. McCarty joined UF Health as the Medical Director of GatorCare in November of 2021, and assumed the role as President of GatorCare on October 31, 2022 upon Dr. Jill Sumfest's retirement.
 - Over the past year, Dr. McCarty has met with the 13 employer groups across UF to determine member experience and to get feedback of how GatorCare is functioning, with hopes of improving service and establishing collaboration in benefits design/performance.
 - Priorities for GatorCare in 2024 include:
 - Access to care
 - Chronic case management
 - Supplement domestic network

- Benefit value proposition
- Improve health outcomes
- Goals for GatorCare in 2024 include:
 - Increase virtual care
 - Employee navigation
 - Risk stratification
 - Expand CCM services
 - o Increase access to care
- Important issues currently being addressed by GatorCare include:
 - o GLP1 Off label use (non-diabetics)
 - Formulary change Pharmacy Benefit Management (PBM) acquisition
 - Drug shortages ADHD
 - Coverage of anti-obesity medications
- Dr. McCarty answered questions and addressed concerns of the Faculty Council members. He
 agreed to provide updates to the Faculty Council following his meeting with the Board of
 Directors in March.

4. New Business:

- Nominations for the 2024 Lifetime Achievement Awards
 - A call for nominations for the 2024 Lifetime Achievement Awards will be sent out soon. This award recognizes our most outstanding, active peers for providing extraordinary service to the UF COM, including recognition for the college through national reputation in their respective professions. - UF Faculty Senate (January 2024 meeting) Lauren Berkow, M.D.
 - After serving as Interim Provost for the past five months, Dr. Scott Angle was named Provost of the University of Florida and has signed on for an 18-month term. Dr. Angle plans to set-up a portal to streamline the requests for funds for projects, and the requests will now go through the CFO's office.
 - Updates were provided regarding the Post-Tenure Review, which is expected to launch this month. Faculty who are up for review will be asked to send an updated CV and should expect responses in early May. More information and details about the process

- will be provided soon.
- The current Faculty Senate Chair, Dr. Danaya Wright, is continuing to work on reducing administrative burdens for faculty.
- o There was further discussion regarding Regulation SB846 on Countries of Concern.
- Dr. David Norton provided an update on the Strategic Plan for Animal and Human Subject Research. Their goal is to make the IRB and IACUC processes better and more user-friendly.
- The Board of Governors recently approved Regulation 9.016, which prohibits universities from spending state or federal funds on DEI programs/activities/policies. There are some exceptions related to student organizations and activities and programs required for accreditation or compliance. The Faculty Senate is awaiting guidance from the General Counsel and Provost about what kind of DEI initiatives they can continue.
- History Professor and Pulitzer Prize winner Jack Davis is the featured speaker at the upcoming Faculty Senate Distinguished Lecture Series to be held at 10am on February 15, 2024 in the UF Senate Chamber at the Reitz Union. Dr. Davis will present a lecture entitled "Coming Ashore: Wonder, Creativity, and the Environmental Humanities".
- Hospital Operations Committee Lisa Spiguel, M.D.
 - The committee is continuing to work on developing a new platform for their meetings.
